RHIP Update: RHIP has been written, copy edited and the Regional Advisory Council had its first review in June 2024, with a final review in September 2024. Once voted for adoption it will come back to the CAC's. The approved version will be sent to OHA in December, to begin in January 2025 for a 5- year period. SHARE Input and Update: Staff summarized what the SHARE Initiative is and how it is different from other funding sources and how it ties into our strategies to support housing region-wide. She introduced SHARE partner grantee, from CAT.

CAT provided an update about what the Healthy Homes program does. He stated that most of the work in all three Counties has been ramps, grab bars, electrical repairs, and water heater issues. The emphasis is on keeping people housed for as long as possible. SHARE funding is flexible and allows Healthy Homes to serve the needs where other funding sources are too restrictive. Currently Healthy Homes has seventeen completions in Columbia County. CAT is open for referrals. Currently replacing septic systems and referrals are welcome for that program.
